ORDER:

The Director of Rural Development and Panchayat Raj has stated that, in the letter read above, the Annual Implementation Plan for the year 2015-16 in respect of Tamil Nadu under Swachh Bharat Mission (Gramin) has been submitted to Government of India. The Government of India has communicated the Minutes of the meeting held on 11.2.2015 on AIP 2015-16 under SBM(G) for State of Tamil Nadu. However, the allocation is yet to be received. In this regard, the Government of India has been informed, vide Director of Rural Development and Panchayat Raj letter Lr.No. 2265/2015/NBA-1, dated 21.7.2015, as proposed in AIP 2015-16, 7,71,781 IHHLs has been takenup during this year. Apart from this, during this year 7,50,944 IHHLs have been proposed to be takenup under MGNREGS. Further, the Government of India has also informed that elaborate action has been takenup to provide all the 15,22,725 IHHLs both under SBM(G) and MGNREGS and the Government is also monitoring the programme on a weekly basis. The Government of India has been requested to allocate required funds of Rs. 925.66 Crore under SBM(G) to the State of Tamil Nadu as per AIP proposal for the 2015-16 so as to achieve the same.

2. The Director of Rural Development and Panchayat Raj has also stated that the Government of India have released Rs.34,91,01,000/- towards the part of first installment of Grant-in-aid under Swachh Bharat Mission (Gramin) for the year 2015-16

Out of the above amount, 2nd instalment of Central Share of Rs.10255.94 lakhs and balance part of 1st instalment and 2nd instalment of the State Matching Share of Rs.4752.64 lakhs for the year 2014-15, totally Rs. 150.086 has been released to Districts during 2015-16 and balance amount of Rs.4991.42 lakhs is available in Budget Estimate 2015-16 as detailed below:

The Director of Rural Development and Panchayat Raj has therefore requested the Government to authorize the Director of Rural Development and Panchayat Raj to draw the amount of Central Share of Rs.34,91,01,000/- (Rupees Thirty Four crores Ninety One lakhs and thousand only) from the Government head of account and to disburse the same to the Districts along with corresponding State Matching share.

5. The Government, after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, accord sanction for a sum of Rs.34,91,01,000/- (Rupees Thirty Four crores Ninety one lakhs and thousand only) towards the part of first instalment of Central share under Swachh Bharat Mission (Gramin) for the year 2015-16.
