## **ORDER:-**

Hon'ble Chief Minister made the following Announcement on the floor of the Legislative Assembly on 3.9.2015 under Rule 110 of the Tamil Nadu Legislative Assembly:

"Formation of 10,000 Self Help Groups during the year 2015-16 under Tamil Nadu State Rural Livelihoods Mission".

2. The Managing Director, Tamil Nadu Corporation for Development of Women Limited has stated that Tamil Nadu Corporation for Development of Women (TNCDW) Limited is the Nodal agency for implementation of the Tamil Nadu State Rural Livelihoods Mission (TNSRLM). The scheme is implemented in 265 blocks in 3 phases during the year 2012-13 onwards. Now, Tamil Nadu Corporation for Development of Women Limited has proposed to form 10,000 New Self Help Groups during the year 2015-16 in 170 Blocks of 31 Tamil Nadu State Rural Livelihoods Mission (TNSRLM) Districts in rural areas focusing on destitute, poor vulnerable, differently abled and scheduled tribe who are not members of any Self Help Groups. Accordingly, for the year 2015-16, 10,000 new Self Help Groups will be formed in 170 blocks of 31 TNSRLM districts by bringing the left out poor, destitute, vulnerable, differently abled and scheduled tribe into the fold of Self Help Groups network identified through the Participatory Identification of Poor (PIP) process.

The Managing Director, Tamil Nadu Corporation for Development of Women Limited has further stated that no fund is required for the formation of new Self Help Groups, since the new Self Help Groups are formed by the Community Organization i.e., Village Poverty Reduction Committee through the Community Self Help Group Trainer (CST).
- 4. The Managing Director, Tamil Nadu Corporation for Development of Women Limited has therefore requested the Government to issue necessary orders for the Formation of 10,000 new Self Help Groups for the year 2015-16.
- 5. The Government after careful examination of the proposal of Managing Director, Tamil Nadu Corporation for Development of Women Limited has decided to accept it and direct the Managing Director, Tamil Nadu Corporation for Development of Women Limited to form of 10,000 new Self Help Groups in 170 Blocks of 31 Tamil Nadu State Livelihoods Mission Districts in rural areas for the year 2015-16.
