### **ORDER:-**

The Hon'ble Chief Minister has made the following Announcement in Tamil Nadu State Legislative Assembly on 03.09.2015 under Rule 110:-

“30,000 இளைஞர்களுக்கு புதுவாழ்வு திட்ட கிராம வறுமை ஒழிப்பு சங்கங்கள் மூலமாக 30 கோடி ரூபாய் செலவில் நடப்பாண்டில் திறன் வளர்ப்பு பயிற்சிகளின் வாயிலாக நிலையான வேலைவாய்ப்புகள் உருவாக்கப்படும் என்பதை பெருமகிழ்ச்சியுடன் தெரிவித்துக் கொள்கிறேன்.”

2. The Project Director, Pudhu Vaazhvu Project (PVP) in her D.O. letter second read above has stated that the Pudhu Vaazhvu Project is being implemented in 26 Districts covering 4174 Village Panchayats of 120 backward Blocks with the support of the World Bank. Harnessing the youth potential is one of the prime strategies the project has followed and proved beyond doubt that channelizing the youth in the right direction by providing them skill training and gainful employment which has a direct impact in the income levels of the poor households. This activity turns to be one of the well proven ways in poverty alleviation.

3. She has further stated that under the Project, rural youth from the target households are identified and Youth Data Base is created for each Panchayat capturing name, age, sex, educational qualification, trade of interest, etc of each youth. Accordingly, counselling is done for the youth to identify a suitable trade of training and placement is arranged on completion of training. Youth Skill Training

activity plays a vital role in increasing income of poor households and thereby reducing the poverty. Considering the importance of skill training and employment, Hon'ble Chief Minister has made an announcement on the floor of Legislative Assembly, that employment avenues for 30,000 youth will be created at a cost by Rs.30.00 crore by imparting Skill Training in the Pudhu Vaazhvu Project areas. The district-wise youth proposed to be covered under youth skill training are as follows:-

The Project Director, Pudhu Vaazhvu Project has therefore requested the Government to issue orders permitting the Pudhu Vaazhvu Project (PVP) to incur an expenditure of Rs.30.00 Crores out of Pudhu Vaazhvu Project funds towards creation of Employment avenues for 30,000 youth by imparting Skill Training in the project areas through Village Poverty Reduction Committee (VPRC).

The Government after careful examination has accepted the proposal of the Project Director, Pudhu Vaazhvu Project and issue orders to permit the Pudhu Vaazhvu Project to take up the above works and to incur an expenditure of Rs.30.00 crores out of Pudhu Vaazhvu Project funds towards creation of Employment avenues for 30,000 youth by imparting Skill Training in the project areas through Village Poverty Reduction Committee (VPRC) subject to adhering to the standards prescribed by the Tamil Nadu Skill Development Corporation and dovetailing of Pudhu Vaazhvu Project funds.
