ORDER:

In G.O. first read above, the Government have accorded sanction for release of a sum of Rs.350,70,78,000/- (Central share Rs.210,42,47,000/-+State matching share Rs.140,28,31,000/-) towards part of first instalment of grants-in-aid under Swachh Bharat Mission (Gramin) for the year 2016-17.

- 2. The Director of Rural Development and Panchayat Raj has also stated that in view of Rs. 200.00 Crore is only available in interim B.E. 2016-17, the Government had provided an additional amount of Rs.150.71 Crore in RBE/RE/FMA 2016-17. As per the orders of Government in first read above, an amount of Rs.350.71 Crore was drawn and disbursed to the Districts as first instalment of grants—in-aid for the implementation of Schemes. As such, there is no provision under SBM (G) in interim B.E for 2016-17.
- 3. The Director of Rural Development and Panchayat Raj in letter fourth read above, has stated that the Government of India have released a sum of Rs.58,08,47,000/- to the State Government towards the balance part of the first

installment of Grant-in-aid as Central Share under Swachh Bharat Mission (Gramin) for the year 2016-17 as detailed below:

- 4. Further, the Director of Rural Development and Panchayat Raj has stated that the Government of India, in the letter third read above, have indicated Rs.537.02 Crore as initial allocation to the State of Tamil Nadu for the execution of work under Swachh Bharat Mission (Gramin) during the financial year 2016-17. As per Government of India's sanction order in the letter second read above the State shall ensure release/transfer of aforesaid amount along with the State Matching share to the implementing agencies within 15 days of its receipts. As per the revised sharing pattern of 60:40 under Swachh Bharat Mission (Gramin), the balance part of first installment of Central Share is Rs.58,08,47,000/-(60%), Corresponding State Matching Share worked out is Rs.38,72,31,000/- (40%).
- 5. The Director of Rural Development and Panchayat Raj has therefore requested the Government to authorize the Director of Rural Development and Panchayat Raj to draw the balance part of the first installment of Central share of Rs. 58,08,47,000/- and also to sanction Corresponding State Matching share

of Rs. 38,72,31,000/- under SBM(G) for the year 2016-17 from the following Government head of account and disburse the same to the Districts:
