







ABSTRACT

Sanitation - Solid Waste Management activities - Announcement made by the Hon'ble Chief Minister under Rule 110 - Implementation of Solid Waste Management activities in the remaining 3,524 Village Panchayats under Phase-III & Provision of additional infrastructure facilities in 9,000 Village Panchayats in Phase I & II Village Panchayats and School toilet maintenance during the year 2016-17 and sanction of a sum of Rs.200 Crore therefor - Orders - Issued.

ORDER:

Hon'ble Chief Minister of Tamil Nadu has made the following announcement under Rule 110 on the floor of Legislative Assembly on 29.08.2016:-

"கிராம ஊராட்சிகளை தூய்மையாகவும், சுகாதாரமாகவும் பராமாிப்பதற்கு எனது தலைமையிலான அரசு தொடா்ந்து முக்கியத்துவம் அளித்து வருகிறது. திடக்கழிவு மேலாண்மைத் திட்டத்தின் கீழ், கழிவுப் பொருட்களை சேகாித்தல், மக்கும் குப்பைகள் மற்றும் மக்காத குப்பைகளாக பிரித்தெடுத்து பாதுகாப்பான முறையில் அப்புறப்படுத்துதல் ஆகிய பணிகளை மேற்கொள்ள 2015—ஆம் ஆண்டு முதல் 'தூய்மைக் காவலாகள்' ஈடுபடுத்தப்பட்டு வருகின்றனா். 9,000 கிராம ஊராட்சிகளில் இத்திட்டம் செயல்படுத்தப்பட்டு வருகிறது. திடக்கழிவுகளை சேகரித்தல், பிரித்தல், அவற்றை பாதுகாப்பாக அகற்றுதல், மறு சுழற்சி செய்தல் ஆகியவற்றிற்கு, மூன்று சக்கர மிதிவண்டிகள்/தள்ளுவண்டிகள், குப்பைத் தொட்டிகள், குப்பைகள் பிரித்தெடுக்கும் கொட்டகைகள் போன்ற அடிப்படை கட்டமைப்பு வசதிகள் மேற்கண்ட ஊராட்சிகளில் ஏற்படுத்தப்பட்டுள்ளன.

இத்திட்டத்தை முன்மாதிரியாகக் கொண்டு செயல்படுத்த பிற மாநில அரசுகளும் நடவடிக்கை மேற்கொண்டு வருகின்றன. இந்த ஆண்டில், மீதமுள்ள 3,524 கிராம ஊராட்சிகளிலும் இந்த திட்டம் விரிவுபடுத்தப்படும். மேலும், ஏற்கெனவே இத்திட்டம் செயல்படுத்தப்படும் கிராம ஊராட்சிகளில் கட்டமைப்பு வசதிகள் மேம்படுத்தப்படும். இவற்றிற்கு 200 கோடி ரூபாய் நிதி ஒதுக்கீடு செய்யப்படும்.

இதன் மூலம், இந்தியாவிலேயே அனைத்து கிராம ஊராட்சிகளிலும் திடக்கழிவு மேலாண்மைத் திட்டத்தினை செயல்பாட்டிற்கு கொண்டு வரும் முதல் மாநிலம் என்ற பெருமை தமிழ்நாட்டிற்கு கிடைக்கும்".

- 2. The Director of Rural Development and Panchyat Raj in the letter seventh read above, has stated that the Government have provided Rs.150 Crore in Revised Budget Estimate 2016-17 for the implementation of Solid Waste Management activities in rural areas. In the Government Order first read above, the Government have issued detailed guidelines for the establishment of Solid Waste Management Systems with recycling and waste disposal facilities in 2,000 Village Panchayats by converging Mahatma Gandhi National Rural Employment Guarantee Scheme Workers as "Thooimai Kaavalars" at the rate of one worker per 150 households for door to door collection of waste, segregation, transporting to disposal pits, etc. As per the earlier announcement of Hon'ble Chief Minister of Tamil Nadu made on the floor of Legislative Assembly under Rule 110 on 3.09.2015 the Government have issued detailed guidelines for extending this scheme to another 7,000 Village Panchayats in Phase II. For collection, segregation and safe disposal of waste, the basic infrastructure like tri-cycle/pushcart, Street Collection Bins and segregation and storage shed have been provided to 9,000 Village Panchayats.
- 3. The Director of Rural Development and Panchayat Raj has also stated that as per the announcement made by the Hon'ble Chief Minister, it is proposed to extend Solid Waste Management activities to the remaining 3,524 Village Panchayats in Phase III thereby making Tamil Nadu as the First State in India converging Mahatma Gandhi National Rural Employment Guarantee Scheme for Solid Waste Management activities in all Village Panchayats and introducing best practices in Rural cleanliness of the State. In this connection the detailed guidelines have been issued by the Government vide G.O.Ms.No.69, Rural Development and Panchayat Raj(CGS.1) Department, dated 16.06.2016 for the continuous implementation of Solid Waste Management activities 9,000 Village Panchayats taken up in Phase I and Phase II during the year

2015-16 may also be adopted for the implementation of Solid Waste Management activities in the remaining 3,524 Village Panchayats. However, Segregation cum Storage Sheds shall be taken up under Mahatma Gandhi National Rural Employment Guarantee Scheme.

- 4. The Director of Rural Development and Panchayat Raj has further stated that the District Collectors have reported that the infrastructure facilities like Street Garbage bins already provided to the Village Panchayats are not adequate to cater the needs of garbage removal that gets accumulated in important street junctions and requested to provide bins at the rate of atleast one bin per habitation and in respect of Village Panchayats with more than 7,500 Population requests have been made for provision of atleast two Bins per habitation. In Tamil Nadu, there are 79,394 habitations in 12,524 Village Panchayats. At present, Solid Waste Management activities are being implemented in 9,000 Village Panchayats covering 61,347 habitations (19,096 habitations under 1st phase + 42,251 habitations under 2nd phase). As per the orders issued in G.O.Ms.No.22, Rural Development and Panchayat Raj(CGS.1) Department, dated 09.02.2016, 36,000 Street Garbage Collection Bins at an unit cost of Rs.25,000/-, with a total cost of Rs.90.00 Crore were sanctioned for the implementation of Solid Waste Management activities in 9,000 Village Panchayats. Hence, 25,347 additional bins are required for provision of one bin per habitation. There are 745 Village Panchayats which are having more than 7,500 population with a total of 11,921 habitations in which Solid Waste Management activities are implemented in Phase I & II Village Panchayats. Remaining 3,524 Village Panchayats containing 18,047 habitations (79,394 - 61,347) are to be provided Street Garbage Collection Bins at the rate of one per habitation.
- 5. In the Government order second read above, the Government have issued detailed guidelines for the maintenance of School toilets in Panchayat Union Schools and Government Schools located in rural areas. It was also ordered therein that the expenditure should be met out from the Solid Waste Management funds as already ordered by the School Education Department in their G.O.(Ms).No.77, School Education(SE-4(1) Department, dated 13.04.2015. Also, the Government have provided Rs. 57.63 Crore in 2015-16 for the maintenance of School Toilets in Panchayat Union Schools and Government Schools located in rural areas. The Government in Letter(D) No.145, Rural Development and Panchayat Raj(CGS-1) Department, dated 1.04.2016 have permitted the Director of Rural Development and Panchayat Raj to utilize the above amount during the financial year i.e. 2016-17 till necessary budget provision is made for the maintenance of School toilets. Hence, available amount will be adequate up to 31.12.2016 and that a sum of Rs. 26.83 Crore is required for the period from 1.01.2017 to 30.06.2017, for the maintenance of School Toilets in Panchayat Union Schools and Government Schools located in rural areas.
- 6. The Director of Rural Development and Panchayat Raj has also stated that the overall requirement for the implementation of Solid Waste Management activities in the remaining 3,524 Village Panchayats in Phase III and also for provision of additional

infrastructure facilities like Street Garbage bins to the Village Panchayats that have already been taken up in Phase I & II are given below:

- 7. The Director of Rural Development and Panchayat Raj has therefore requested the Government to issue orders,
 - a) to sanction a sum of Rs.200 Crore for the implementation of the Solid Waste Management activities in the remaining 3,524 Village Panchayats under Phase III in Tamil Nadu, provision of additional infrastructure facilities in Phase I & II Village Panchayats and School toilet maintenance during the year 2016-17;
 - b) to authorize the Director of Rural Development and Panchayat Raj to draw the amount of Rs.150.00 Crore provided in Revised Budget Estimate 2016-17 from the relevant head of account and permit him to utilize Rs.50.00 Crore from the State Finance Commission(SFC) grant due to Rural Local Bodies from Village Panchayats share and disburse the same to the Districts; and
 - c) to adopt Guidelines already issued in G.O.(Ms)No.69, Rural Development and Panchayat Raj(CGS.1) Department, dated 16.06.2016, wherein the Government have issued Guidelines for the implementation of Solid Waste Management activities 9,000 Village Panchayats in rural areas during the year 2016-17.
- 8. The Government after careful examination of the proposal of the Director of Rural Development and Panchayat Raj have decided to accept the same and accordingly issue the following orders:
 - a) Sanction is accorded for a sum of Rs.200 Crore for the implementation of the Solid Waste Management activities in the remaining 3,524 Village Panchayats under Phase III in Tamil Nadu, provision of additional infrastructure facilities in Phase I & II Village Panchayats and School toilet maintenance during the year 2016-17, subject to the condition that the existing and future commitment from Solid Waste Management for Swachh Bharat Mission(Gramin) be adjusted before the issuance of administrative sanction for these schemes.

b) The Director of Rural Development and Panchayat Raj Chennai is authorized to draw the amount of Rs.150.00 Crore provided in Revised Budget Estimate 2016-17 from the following head of account:-

and also permitted to utilize Rs.50.00 Crore from the State Finance Commission(SFC) grant due to Rural Local Bodies from Village Panchayats share and disburse the same to the Districts.

- c) Permission is also accorded to adopt Guidelines already issued in G.O.(Ms)No.69, Rural Development and Panchayat Raj(CGS.1) Department, dated 16.06.2016, wherein the Government have issued Guidelines for the implementation of Solid Waste Management activities for 9,000 Village Panchayats in rural areas during the year 2016-17.
- 9. This order issues with the concurrence of Finance Department vide it's U.O.No.56348/RD/2016, Finance(RD) Department, dated 21.10.2016.
