### **ORDER:**

The Hon'ble Chief Minister had announced that a housing scheme will be implemented at the cost of Rs.300 crore and 10,000 concrete houses will be constructed for the poor people living in Koodankulam and neighbouring villages in Tirunelveli District from the year 2013-14 to 2015-16.

2. In the G.O.(Ms).No.95, Rural Development and Panchayat Raj (CGS2) Department, dated 26.7.2013, 10,000 houses have been sanctioned for the people who are living adjacent to Koodankulam Nuclear Power Project(KKNPP) in 13 Village Panchayats namely 1.Kuttam, 2.Uvari, 3.K.Uvari, 4.Koothankuli, 5.Vjayapathi, 6.Parameshwarapuram, 7.Uthayathur, 8.Thiruvambalapuram, 9.Koodankulam, 10.Levenchipuram, 11.Chettikulam, 12.Irukkanthurai and 13.K.Navaladi.

It was also ordered that the houses will be constructed in a phased manner as below:-

The Director of Rural Development and Panchayat Raj has stated that the District Collector, Tirunelveli in his letter dated 15.12.2014 has stated that 5,000 beneficiaries were selected by the Selection Committee for the year 2013-14 and administrative sanction has been accorded and work orders issued to the beneficiaries and it will not be possible to execute the work with the existing staff available in the District in addition to the routine job since the number of houses under the scheme are more. He has therefore requested to sanction 34 additional staff in order to improve the quality of construction and ensure speedy execution. He has also stated that, as the scheme is implemented for a short period, it is felt that exclusive regular posts need not be created. However, the required staff may be posted on outsourcing basis with required qualification as detailed below who may be paid salary on consolidated basis.

4. He has further stated that the above posts may be created for a period of 3 years from the date of issue of order. The amount required for the posts to be filled up on consolidated pay will be Rs.56,16,000/- per annum. The scheme is funded by the Department of Atomic Energy, Government of India and funds are released through Nuclear Power Corporation of India Limited (NPCIL) from time to time.

So far, a sum of Rs.75 crore has been released to the District Collector, Tirunelveli from NPCIL for the scheme. Hence, the expenditure for the above 34 posts may be met out from the interest amount of the scheme fund and there will not be any financial commitment to the State Government. He has requested the Government to issue necessary orders to permit the District Collector, Tirunelveli to appoint additional staff for Koodankulam Nuclear Power Project (KKNPP) - Neighbourhood Development Programme (NDP) housing scheme so as to expedite construction of houses.

5. The Government after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, issue orders to recruit 29 additional staff on consolidated basis for construction of 10,000 houses for Koodankulam Nuclear Power Project (KKNPP) - Neighbourhood Development Programme (NDP) for the period of three years from the date of issue of this order. The expenditure incurred to pay 29 personnel are met out from the interest amount of the scheme fund and to permit the District Collector, Tirunelveli to appoint them as given below:
