ORDER:

The Hon'ble Chief Minister has made the following Announcement on the floor of the Tamil Nadu State Legislative Assembly on 03.09.2015 under Rule 110:-

"ஒரு பகுதியில் ஒரே வகை உற்பத்தி நடவடிக்கைகளில் ஈடுபட்டு வரும் சுய உதவிக் குழு உறுப்பினர்களை ஒருங்கிணைத்து ஒத்த தொழில் குழு உருவாக்கப்படுகிறது. ஒவ்வொரு தொழில் குழுவிற்கும் பொதுவான உட்கட்டமைப்பு வசதிகள், அங்காடி வசதிகள் மற்றும் தனித் திறன் மேம்பாட்டுப் பயிற்சிகள் வழங்குவதற்காக ஊக்க நிதி வழங்கப்படுகிறது. இதன் அடிப்படையில் கிராமப்புறங்களில் ஒரே தொழிலை மேற்கொள்ளும் சுய உதவிக் குழுக்களை ஒருங்கிணைத்து அவர்களுக்கு தேவைப்படும் உட்கட்டமைப்பு வசதிகளை ஏற்படுத்திட குழுவிற்கு தலா 1 லட்சம் ரூபாய் வீதம் 1500 ஒத்த தொழில் குழுக்களுக்கு 15 கோடி ரூபாய் நிதி உதவி தமிழ்நாடு புதுவாழ்வு திட்டத்தின் மூலம் வழங்கப்படும் என்பதை பெருமகிழ்ச்சியுடன் தெரிவித்துக் கொள்கிறேன்."

2. The Project Director, Pudhu Vaazhvu Project in her D.O. letter second read above, has stated that the Tamil Nadu Pudhu Vaazhvu Project (TNPVP) is being implemented in 26 Districts, covering 4174 Village Panchayats in 120 backward Blocks. The Project has promoted Primary

Level Institutions such as Village Poverty Reduction Committee (VPRC), Panchayat Level Federation (PLF), Social Audit Committee (SAC) and Common Livelihood Groups (CLGs) which are pro-poor local institutions having specific roles and functions to implement the programmes with effective community participation. The target people consisting of poor and other disadvantaged groups have received capacity building, institution development, social assistance, employment and livelihood development benefits. The target poor have also received assistance through VPRC and PLF directly accessing funds. These institutions have extended their services to the target people by enabling and empowering them for increasing their capacities, skills and developing their livelihoods.

She has further stated that as per the announcement made by the Hon'ble Chief Minister under rule 110 on the floor of Tamil Nadu Legislative Assembly on 03.09.2015, it is proposed for formation of 1500 Common Livelihood Groups (CLGs) by integrating the members of SHGs involved in similar activities. Each CLG will be provided Rs.1.00 Lakh as financial assistance for creation of common infrastructure facilities depending on their needs, training and exposure visit for their skill development to do the activity to enhance their existing income level and sustainability.

The Project Director, Pudhu Vaazhvu Project has further stated that a sum of Rs.15.00 crores towards Common Livelihood Group infrastructure fund as indicated in the above districts will be released from the Project funds and no separate fund is required from State Exchequer. She has therefore requested the Government to issue necessary orders for implementation of the above proposal.

The Government after careful examination of the proposal of the Project Director, Pudhu Vaazhvu Project has accepted and issue order for formation of 1500 Common Livelihood Groups (CLGs) and sanction of Rs.1.00 lakh to each Common Livelihood Group at a total cost of Rs.15.00 crores by utilizing the Pudhu Vaazhvu Project funds towards CLG infrastructure fund as detailed below:
