ORDER:

Hon'ble Chief Minister had announced on the floor of Tamil Nadu Legislative Assembly on 28.9.2015 under Rule 110, that

"in Tamil Nadu, there are 6.08 lakh women Self Help Groups (SHGs) comprising 92 lakh members. The SHGs are federated Panchayat wise into Panchayat Level Federation (PLF). Each PLF has 20 to 25 SHGs in its fold. There are 20,000 Community SHG Trainers (CSTs) and they supervise 10-15 SHGs each. In order to assist the CSTs in the conduct of SHG meetings and e-bookkeeping, an application in Tamil will be developed and loaded on to Mobile Phones which will be given to them through a new scheme called 'Amma Kaipesi Scheme' (அம்மா கைபேசி திட்டம்)."

Pursuant to the above announcement of Hon'ble Chief Minister and on the proposal of the Managing Director, TNCDW Ltd., dated 29.9.2015, orders have been issued in the G.O. first read above for the implementation of new scheme called 'Amma Kaipesi Scheme (அம்மா கைபேசி திட்டம்)' for providing mobile handsets to 20000 Community SHG Trainers at a cost of Rs.15.00 crores to be met out from the funds of TNCDW Ltd.

2. In continuation of the orders issued above, the Managing Director, TNCDW Limited in the d.o. letter second read above, has submitted proposal for issuing necessary guidelines for the implementation of the 'Amma Kaipesi Scheme (مَسْعَانَهُ)' and the procedure for procurement of hardware and software. The Managing Director, TNCDW Limited has solicited orders of Government on the following:-

(1)Grouping of items in 3 categories Viz.,

- (a) Handset & Allied, Mobile Application,
- (b) Server and
- (c) Service Provider

(2)Breakup Cost:

- (i) Category-1- Rs. 12 Crores for Mobile Handsets, Mobile Application, Online Application and Training;
- (ii) Category-2 Rs.50 lakhs for Server, Database including Disaster recovery database maintenance / upkeep at alternate specified Government owned / approved other data centre locations;
- (iii) Category-3 Rs. 2.5 Crores for SIM Services
- (3) For the formation of a committee to approve technical specifications for procurement of handsets, software and server.
- (4) For the formation of a Procurement Committee under the chairpersonship of MD, TNCDW to invite tender and to evaluate the financial proposals.
- (5) For placing the decision of the Procurement Committee before the TNCDW Board for Tender approval.

- (i)The Board of TNCDW Limited has the nominee of Finance Department & so the Tender Documentation and the evaluation should be done by a Technical Committee consisting of Director of E-Governance, MD(TNCDW) and the relevant ADRD and after this, the evaluated bids may be placed before the TNCDW Board for Acceptance;
- (ii) The Costs and payment terms should be separated as the award criteria and the rest may be termed as Qualification criteria.
- (iii) The Bid Document containing eligibility, qualification and other criteria should be pre-scrutinized by the Board.

4. Hence, the Government hereby accept the proposal of Managing Director, TNCDW Limited as detailed in para-2 above pertaining to (1) Procurement & supply of materials; (2) Breakup cost workouts; (3) Formation of Technical Specification approval Committee; (4) Formation of Procurement Committee; and (5) Placing the decision on Tender Approval of Procurement Committee through TNCDW Board and issue orders accordingly.
