## ORDER:

In the letter read above, the Director of Rural Development and Panchayat Raj has stated that Ministry of Rural Development has released a sum of Rs.1,81,98,500/-(Rupees One Crore Eighty One Lakh Ninety Eight Thousand and Five Hundred only) towards "Administrative Funds" to State Government of Tamil Nadu under Pradhan Mantri Gram Sadak Yojana (PMGSY) for 2017-18.

- 2. The Director of Rural Development and Panchayat Raj has therefore requested the Government to issue order for the release of Rs.1,81,98,500/- (Rupees One Crore Eighty One Lakh Ninety Eight Thousand and Five Hundred only) released by the Government of India, Ministry of Rural Development.
- 3. The Government, after careful examination, have decided to accept the proposal of the Director of Rural Development and Panchayat Raj and accord sanction to release a sum of Rs.1,81,98,500/- (Rupees One Crore Eighty One Lakh Ninety Eight Thousand and Five Hundred only) as released by the Government of India, Ministry of Rural Development, to the State Government of Tamil Nadu towards 1st Instalment of Administrative Funds under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the year 2017-18.

4. The expenditure sanctioned in para 3 above shall be debited under the following head of account:-

"4515-00-Capital outlay on other Rural Development Programmes - 103 - Rural Development - State's Expenditure - JG-Roads/ Bridge works under PMGSY - Bharat Nirman - 16 - Major Works (DPC 4515 - 00-103-JG-1608)"

- 5. The Director of Rural Development and Panchayat Raj is authorized to draw and transfer the amount sanctioned in para 3 above to Tamil Nadu Rural Housing and Infrastructure Development Corporation.
