As 227 works have been completed out of 407 total works, the State contribution amount of Rs.28.76 Crore needs to be released for completion of the remaining works. He has also stated that in BE 2017-18, a sum of Rs.758.44 Crore has been provided for implementation of PMGSY Scheme for the year 2017-18.

- 3. The Director of Rural Development and Panchayat Raj has therefore requested the Government
  - to issue orders for the release of Rs.28.76 Crore (Rupees Twenty eight crore seventy six lakh only) (RD portion) as State share under Pradhan Mantri Gram Sadak Yojana Phase IX under the following head of account:

"4515-00-Capital outlay on Other Rural Development Programmes - 103 - Rural Development - State's Expenditure - JG-Roads/Bridge works under PMGSY - Bharat Nirman - 16 - Major Works

- ii. to draw and transfer the above said amount to Tamil Nadu Rural Housing and Infrastructure Development Corporation account.

The Government after careful examination have decided to accept the proposal of Director of Rural Development and Panchayat Raj and accord sanction a sum of Rs.28.76 Crore (Rupees Twenty eight crore seventy six lakh only) (RD portion) as State share under Pradhan Mantri Gram Sadak Yojana Phase IX during 2016-17.
