ORDER:

In the Government order first read above, the Government accorded Administrative Sanction for the road works taken up under Pradhan Mantri Gram Sadak

Yojana Phase VIII (2012-13) / Bharat Nirman Phase III for Rs.1130.10 Crores and maintenance cost for Rs.01.91 Crores. Based on the Government order, the Ministry of Rural Development has released Rs.343.48 Crore in 2013-14, which was directly credited to Tamil Nadu Rural Housing and Infrastructure Development Corporation (SRRDA) account as per the rule in vogue at that time.

2. In the Government order second read above, a sum of Rs.100 crore has been released as grants-in-aid to Tamil Nadu Rural Housing and Infrastructure Development Corporation towards part payment of 1st instalment under Phase VIII of PMGSY for the financial year 2014-15 as per the restructured programme. In the Government order third read above, a sum of Rs.121.89 Crore has been released as grants-in-aid to Tamil Nadu Rural Housing and Infrastructure Development Corporation towards balance of 1st instalment and part payment of 2nd instalment under Pradhan Mantri Gram Sadak Yojana Phase VIII for the year 2014-15. In the Government order fourth read above, a sum of Rs.15.00 Crore has been released as grant-in-aid to Tamil Nadu Rural Housing and Infrastructure Development Corporation towards part payment of 2nd instalment under Phase VIII of Pradhan Mantri Gram Sadak Yojana for the financial year 2014-15. In the Government Order fifth read above, a sum of Rs.53.00 crore has been released as grants-in-aid to TNRHIDC towards part payment of 2nd instalment under Phase VIII of Pradhan Mantri Gram Sadak Yojana for the financial year 2015-16. In the Government Order sixth read above a sum of Rs.1.5776 Crore has been released as grants-in-aid to Tamil Nadu Rural Housing and Infrastructure Development Corporation towards part payment of 2nd instalment under Phase VIII of Pradhan Mantri Gram Sadak Yojana for the financial year 2015-16. In the Government order seventh read above, a sum of Rs.34.86 Crore has been released as central assistance under Pradhan Mantri Gram Sadak Yojana Phase VIII part payment of 2nd instalment for the financial year 2015-16. In the reference Government Order eighth read above a sum of Rs.27.13 Crore has been released as Central assistance under PMGSY Phase VIII for the financial year 2015-16. In the reference Government Order ninth read above, a sum of Rs.37.86 crore has been released as Pradhan Mantri Gram Sadak Yojana grants to Tamil Nadu Rural Housing and Infrastructure Development Corporation as central assistance for PMGSY Phase VIII. In the reference Government Order tenth read above, a sum of Rs.45.9575 Crore has been released as PMGSY grants to Tamil Nadu Rural Housing and Infrastructure Development Corporation for PMGSY Phase VIII. In the reference eleventh read above, a sum of Rs.4.615 Crore has been released as PMGSY grants to Tamil Nadu Rural Housing and Infrastructure Development Corporation for PMGSY Phase VIII.

3. In the letter thirteenth read above, the Director of Rural Development and Panchayat Raj has stated that the Director(RC), Ministry of Rural Development, Government of India has released Rs 39.09 Crore (Rupees Thirty nine crores and nine lakh only) to the State Government of Tamil Nadu as central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the Financial Year 2016-17 and this amount would be adjusted against a specific Phase / Batch during the regular release of 1st instalment under PMGSY for the financial year 2016-17, the Director of Rural Development and Panchayat Raj has therefore requested to transfer the fund to Tamil Nadu Rural Housing and Infrastructure Development Corporation (TNRHIDC) within 3 days from the date of receipt of funds, failing which further releases will be stopped and the State Government is liable to pay interest @ 12% for the period of delay.

4. After careful examination, the Government accept the proposal of the Director of Rural Development and Panchayat Raj and accordingly release a sum of Rs.39.09 Crores (Rupees Thirty nine Crores and nine lakh only) released by Government of India to the State Government of Tamil Nadu as Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the financial year 2016-17.

5. The expenditure sanctioned in para 4 above shall be debited under the following head of account:-

"4515-00-Capital outlay on other Rural Development Programmes - 103 - Rural Development - Schemes in the Twelfth Five Year Plan-II-State Plan - JG-Roads/ Bridge works under PMGSY - Bharat Nirman - 16 - Major Works (DPC 4515 - 00-103-JG-1608)"

6. The Director of Rural Development and Panchayat Raj is authorized to draw and transfer the amount sanctioned in para 4 above to Tamil Nadu Rural Housing and Infrastructure Development Corporation.

7. This order issues with the concurrence of Finance Department vide its U.O.No.28540/Finance (RD)/2016, Dated 09.05.2016.
