Pradhan Mantri Awaas Yojana(Gramin) – Pradhan Mantri Awaas Yojana(Gramin) 2016-17. 1st installment of Central share including 4% Administrative cost of Rs.493,57,53,000/- sanctioned by Ministry of Rural Development – 1st installment of State share for houses Rs.316,39,44,000/- and 4% Administrative cost of Rs.12,65,57,760/- and 1st installment of RCC roofing cost of Rs.329,57,75,000/- totaling Rs.658,62,76,760/- - Release of funds – Sanction accorded – Orders - Issued.

ORDER:

The Director of Rural Development and Panchayat Raj in the letter third cited, has stated that as per the Deputy Secretary, Ministry of Rural Development, Government of India Letter No.J-11014/1/2014-RH (Part-1) dated 07.04.2016, Indira Awaas Yojana the rural housing scheme has been revamped to Pradhan Mantri Awaas Yojana(Gramin) and the new scheme has been approved by the Cabinet on 23.03.2016 and enhanced the unit assistance from Rs.70,000/- to Rs.1,20,000/-. Further, in the Letter No.G-20011/01/2015-RH(A/C); 340279, dated 28.06.2016, the Director(Rural Housing), Ministry of Rural Development, Government of India have communicated the physical target of 1,31,831 houses and financial allocation of

Rs.1581.972 Crore for Tamil Nadu for the year 2016-17 under Pradhan Mantri Awaas Yojana(Gramin) (erstwhile Indira Awaas Yojana). In the Letter No.G-12034/03/2016-RH(A/C)-2,2/A,2/B-Tamilnadu, dated 16.09.2016, the Deputy Secretary(Rural Housing), Ministry of Rural Development, Government of India have confirmed the total target of 1,31,831 houses under Pradhan Mantri Awaas Yojana(Gramin) 2016-17 and sanctioned Rs.493,57,53,000/- (Rupees four hundred and ninety three crore fifty seven lakhs and fifty three thousand only) including 4% Administrative cost as the 1st installment of Central Assistance for the implementation of the Pradhan Mantri Awaas Yojana(Gramin) for the year 2016-17 and also instructed that the respective State share should also be released within 15 days from the date of release of Central share.

2. In the Government Order first read above, Government have accorded sanction for a sum of Rs.493,57,53,000/- (Rupees four hundred and ninety three crore fifty seven lakhs and fifty three thousand only) towards 1st installment of Central share including 4% Administrative cost under Pradhan Mantri Awaas Yojana(Gramin) for the year 2016-17. In the Government Order second read above, Government have issued necessary orders for enhancement of unit cost from Rs.1,20,000/- to Rs.1,70,000/- per house including R.C.C roofing cost under Pradhan Mantri Awaas Yojana(Gramin) for the financial year 2016-17 onwards as detailed below:-

3. The Director of Rural Development and Panchayat Raj has stated that as per the Revised Budget Estimate, Rs.1.70 lakhs is allotted for each house constructed under Pradhan Mantri Awaas Yojana(Gramin) for the year 2016-17. The expenditure on the implementation of the programme is to be shared on 60:40 basis between the Central and State as below:-

Accordingly, the State share and 50% of the State share to be released as 1st installment for Pradhan Mantri Awaas Yojana(Gramin) -2016-17 has to be calculated as followed:-

The Director of Rural Development and Panchayat Raj has therefore requested the Government to issue necessary orders for the release of 40% of the State Matching share amount and 50% State RCC roofing cost i.e., Rs.658,62,76,760/- (Rs.316,39,44,000/- for houses, Rs.12,65,57,760/- for 4% Administrative Cost of State share and Rs.329,57,75,000/- for State RCC Roofing cost) as 1st installment of State Share under Pradhan Mantri Awaas Yojana(Gramin) for the year 2016-17 and to authorize him to draw the above fund.

5. The Government after careful examination of the proposal of the Director of Rural Development and Panchayat Raj have decided to accept the same and sanction is accorded to release the 40% of the State share amount and 50% State RCC roofing cost i.e. Rs.658,62,76,760/- (Rs.316,39,44,000/- for houses, Rs.12,65,57,760/- for 4% Administrative Cost of State share and Rs.329,57,75,000/- for State RCC Roofing cost) as 1st installment of State Share under Pradhan Mantri Awaas Yojana(Gramin) for the year 2016-17.

6. The Government have authorized the Director of Rural Development and Panchayat Raj, Chennai to draw and disperse the above said amount

of Rs.658,62,76,760/- provided in Revised Budget Estimate 2010-17 from the following head of account:-
