**ORDER:**

In the letter fourth read above, the Director of Rural Development and Panchayat Raj has stated that Ministry of Rural Development, Director (RH)'s Letter No.G-20011/01/2015-RH (A/C):340279, dated 28.06.2016, the Government of India have communicated the physical target of 1,31,831 houses and financial allocation of Rs.1581.972 Crore for Tamil Nadu for the year 2016-17 under Pradhan Mantri Awaas Yojana(Gramin). Further, Government of India has sanctioned Rs.493,57,53,000/- including 4% administrative cost as the 1<sup>st</sup> Instalment of Central assistance under Pradhan Mantri Awaas Yojana(Gramin) 2016-17 for 1,31,831 houses vide Letters No.G-12034/03/2016-RH(A/C)-2, 2/A, 2/B-TN, dated 16.9.2016 of Deputy Secretary(RH), Ministry of Rural Development, Government of India. In the Government Order first read above, Government have accorded sanction for a sum of Rs.493,57,53,000/- towards 1<sup>st</sup> instalment of Central Share including 4% administrative cost under Pradhan Mantri Awaas Yojana(Gramin) for the year 2016-17. Further, in the Government Order second read above, Government have accorded sanction for a sum of Rs.658,62,76,760/- towards the 1<sup>st</sup> Instalment of State Share including 4% administrative cost and State RCC Roofing cost under

2. The Director of Rural Development and Panchayat Raj has stated that Government of India, Ministry of Rural Development has communicated vide D.O. Letter No.G-20011/ 01/2015-RH(A/C) of Additional Secretary to Government of India, Ministry of Rural Development, Government of India, dated 25.01.2017, an additional target of 44,507 houses under Pradhan Mantri Awaas Yojana(Gramin) for the year 2016-17, in addition to the initial target of 1,31,831 and thus total allotment of houses is 1,76,338 houses for the FY 2016-17. The additional target communicated from Government of India has been re-distributed among the districts vide Director of Rural Development and Panchayat Raj's Proceedings No.21030/2016/RHS 2-1, dated 9.02.2017. Now, Government of India, Ministry of Rural Development has sanctioned a sum of Rs.63,08,21,000/- as part of 1<sup>st</sup> Instalment towards additional target of 44507 houses for the year 2016-17 as detailed below:-

The Director of Rural Development and Panchayat Raj has also stated that necessary budget provision has been made for the FY 2017-18 for Pradhan Mantri Awaas Yojana(Gramin) Scheme and vote on account for eight months has been passed by Legislative Assembly vide G.O.(Ms)No.77, Finance(Budget General) Department, dated 30.03.2017 Government have issued orders for continuance of Quarterly Control of Appropriation for the FY 2017-18 vide G.O.(Ms)No.78, Finance(Budget Co-ordination) Department, dated 30.03.2017.

4. The Director of Rural Development and Panchayat Raj has therefore requested the Government to accord sanction for a sum of Rs.147,25,47,080/- (Central Share Rs.63,08,21,000/- (60%)+ State Share Rs.42,05,26,080/- (40%)+ State Additional Fund for RCC Roofing cost Rs.42,12,00,000/-) and issue necessary orders empowering the Director of Rural Development and Panchayat Raj to draw the above funds towards the part of 1<sup>st</sup> Instalment of Central and State assistance towards additional target of 44507 houses under Pradhan Mantri Awaas Yojana(Gramin) for the FY 2016-17.

5. The Government, after careful examination of the proposal of the Rural Development and Panchayat Raj Department, accord sanction for a sum of Rs.105,13,47,080/-(One hundred five crore thirteen lakh forty seven thousand and eighty only) (Central Share Rs.63,08,21,000/-(60%) + State Share Rs.42,05,26,080/-(40%)) towards the part of 1<sup>st</sup> Instalment of Central and State assistance towards additional target of 44507 houses under Pradhan Mantri Awaas Yojana(Gramin) for the FY 2016-17, excluding the roofing cost and authorize the Director of Rural Development and Panchayat Raj to draw the fund from the Pay and Accounts Officer (South), Chennai from the Head of Account mentioned below:
