ORDER:

In the letter third read above, the Director of Rural Development and Panchayat Raj has stated that vide D.O. Letter No.G-20011/01/2015-RH(A/C), dated 25.01.2017 of Additional Secretary, Ministry of Rural Development, Government of India allotment of 44507 houses under Pradhan Mantri Awaas Yojana(Gramin) for the year 2016-17, in addition to the initial target of 1,31,831 houses. The total allotment of houses is to 1,76,338 houses for the FY 2016-17 and the additional target communicated from Government of India has been re-distributed among the districts vide Director of Rural Development and Panchayat Raj's Proceedings No.21030/2016/RHS 2-1, dated 9.02.2017. The Government of India, Ministry of Rural Development has sanctioned a sum of Rs.63,08,21,000/- as part of 1st Instalment towards additional target of 44507 houses for the year 2016-17. The Government have sanctioned a sum of Rs.105,13,47,080/- [Central Share Rs.63,08,21,000/- (60%) + State Share Rs.42,05,26,080/- (40%)] towards the part of 1st Instalment of Central and State Share under Pradhan Mantri Awaas Yojana(Gramin) for the year 2016-17, excluding the roofing cost vide G.O.(Ms) and Panchayat Raj(CGS1) Department, dated Development No.61, Rural 09.06.2017. ..2.

2. The Director of Rural Development and Panchayat Raj has also stated that Government of India, Ministry of Rural Development has sanctioned a sum of Rs.103,55,20,900/- as balance part of 1st Instalment towards additional target of 44507 houses under Pradhan Mantri Awaas Yojana(Gramin) for the year 2016-17 as detailed below:-

Since, the Government of India, Ministry of Rural Development has released a sum of Rs.103,55,20,900/- as balance part of 1st instalment towards additional target of 44,507 houses under PMAY(G) FY 2016-17, the proportionate State Share(40%) and State additional fund for RCC Roofing Cost are to be sanctioned.

- 3. The Director of Rural Development and Panchayat Raj has further stated that necessary budget provision has been made for the FY 2017-18 for PMAY(G) Scheme and vote on account for eight months has been passed by Legislative Assembly vide G.O.(Ms) No.77, Finance(Budget Co-ordination) Department, dated 30.03.2017. Government have also issued orders for continuance of Quarterly Control of Appropriation for the FY 2017-18 vide G.O.(Ms) No.78, Finance(Budget General) Department, dated 30.03.2017.
- 4. The Director of Rural Development and Panchayat Raj has therefore requested the Government to issue orders for sanction a sum of Rs.241,73,64,540/- (Central Share Rs.103,55,20,900/- (60%) + State Share Rs.69,03,68,640/- (40%)+ State Additional Fund for RCC Roofing Cost Rs.69,14,75,000/-) and empowering the Director of Rural Development and Panchayat Raj to draw the above funds towards the balance part of 1st Instalment of Central and State Share towards additional target of 44507 houses under PMAY(G) FY 2016-17.
- 5. The Government, after careful examination of the proposal of the Director of Rural Development and Panchayat Raj accord sanction for a sum of Rs.172,58,89,540/- [Central Share Rs.103,55,20,900/-(60%) + State Share Rs.69,03,68,640/-(40%)] towards the balance part of 1st Instalment of Central and State Share towards additional target of 44507 houses under Pradhan Mantri Awaas Yojana(Gramin) for the year 2016-17, excluding the roofing cost.
