### ORDER:

In the letter 2<sup>nd</sup> read above, the Director of Rural Development and Panchayat Raj has stated that the Director (RH), Ministry of Rural Development, Government of India in Letter No.J-12034/03/2016-RH (A/c), dated 13.03.2018 and 16.03.2018 have released a sum of Rs.644,93,26,100/- including 4% admin cost directly to State Nodal Account of Tamil Nadu as 2<sup>nd</sup> installment towards central assistance for the year 2016-17 under Pradhan Mantri Awaas Yojana(Gramin), leaving a balance of Rs.15,27,69,000/-. The above amount has been credited into State Nodal Account on 14.03.2018 (Rs.318.22 crore) and 19.03.2018 (Rs.326.72 crore).

Subsequently in the Government Order 1<sup>st</sup> read above the Government have sanctioned and release a sum of Rs.880,98,46,480/- (State share of Rs.440,13,96,480 + State Additional fund for RCC Roofing cost of Rs.440,84,50,000) towards the 2<sup>nd</sup> installment of State share under Pradhan Mantri Awaas Yojana(Gramin) for the year 2016-17.
- 3. The Director of Rural Development and Panchayat Raj has also stated that in Letter No.J-12034/03/2016-RH (A/c), 2, 2A & 2B dated 02.05.2018 the Government of India has accorded sanction for the balance amount of Rs.15,27,69,000/- as Central assistance under Pradhan Mantri Awaas Yojana(Gramin) 2016-17 as detailed below and this amount has been credited into the State Consolidated account.

The Government, after careful examination of the proposal of the Director of Rural Development and Panchayat Raj accord sanction and release a sum of Rs.15,27,69,000 /- (Fifteen Crore twenty seven Lakh sixty nine Thousand only) towards the balance amount of 2<sup>nd</sup> installment of Central share under Pradhan Mantri Awaas Yojana(Gramin) for the year 2016-17 and authorize the Director of Rural Development and Panchayat Raj to draw the fund from the Pay and Accounts Officer (South), Chennai from the Head of Account mentioned below:-
