



ABSTRACT

Pradhan Mantri Awaas Yojana(Gramin) Special Project(Floods) 2016-17 - Special Project for houses damaged by floods in Tamil Nadu - Second Installment of State Additional Fund for RCC Roofing cost of Rs.114,47,00,000/- (One hundred and fourteen crore forty seven lakh only) - Sanction accorded – Orders – Issued.

ORDER:

The Director of Rural Development and Panchayat Raj, in letter fifth read above, has stated that the total target under PMAY(G) Special Project (Floods) for Tamil Nadu is 45,788 and the total Central allocation for the year 2016-17 is Rs.200,00,19,840/-. The Government of India had sanctioned a sum of Rs.100,00,09,000/- as the 1st Installment of Central Assistance including 4% Admin cost. Subsequently, in the Government Order first read above, the State Government had accorded sanction for the release of corresponding 1st installment of state share including 4% Admin cost and State additional fund for RCC Roofing cost amounting to Rs.181,13,73,280/- (State Share - Rs.66,66,73,280/- + RCC Roofing Cost - Rs.114,47,00,000/-).

2. In the Government Order second read above the Government had issued orders for enhancement of unit cost from Rs.1.20 Lakh to Rs.1.70 Lakh per house including RCC Roofing cost under PMAY(G) Special Project (Floods) in order to have

uniformity between PMAY(G) Special Project (Floods) & Regular PMAY(G) Scheme. Accordingly, the Director of Rural Development and Panchayat Raj had accorded sanction for the release of 1st installment of Rs.114,47,00,000/- as Special State Additional share for housing under PMAY(G) Special Project (Floods) in accordance with the powers delegated in G.O.(Ms) No.8, RD&PR(SGS-1) Department, dated 29.01.2007.

3. The Director of Rural Development and Panchayat Raj has stated that, Government of India have sanctioned a sum of Rs.100,00,10,800/- as 2nd Installment of Central share including 4% Administrative cost under PMAY(G) Special Project (Floods) for the year 2016-2017. Subsequently, in the Government Order fourth read above the Government had accorded sanction for the release of Rs.281,13,84,080/- as 2nd Installment of State share under PMAY(G) Special Project (Floods) for the year 2016-17, leaving a balance amount of the 2nd Installment of State additional fund for RCC Roofing cost of Rs.114,47,00,000/-.

4. The Director of Rural Development and Panchayat Raj has further stated that most of the houses taken under PMAY(G) Special Project (Floods) are in advance and nearly completion stage. As per Awaas Soft report dated 04.04.2018 under PMAY(G) Special project (Floods), the details of bills paid to beneficiaries and house completion are detailed below:-

➤ 1 st Inst. bills paid (Basement)	:	45,516
➤ 2 nd Inst. bills paid (Lintel level)	:	42,230
➤ 3 rd Inst. bills paid (Roof laid)	:	36,949
➤ 4 th Inst. bills paid (Completed)	:	24,769
➤ Houses completed (Physically completed)	:	25,508

5. The Director of Rural Development and Panchayat Raj has therefore requested the Government to accord sanction for a sum of Rs.114,47,00,000/- as 2nd Installment of State Additional Fund for RCC Roofing cost under PMAY(G) Special Project (Floods) for the year 2016-17.

6. The Government, after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, accord sanction for a sum of Rs.114,47,00,000/- (One hundred and fourteen crore and forty seven lakh only) as 2nd Installment of State Additional Fund for RCC Roofing cost under PMAY(G) Special Project (Floods) for the year 2016-17.

7. The expenditure sanctioned in para 6 above shall be debited under the following head of account :-


