ORDER:

Raj has stated that the Ministry of Rural Development, Government of India had communicated the physical larget of 1,31,831 houses for the year 2016-17 under PMAY(G). In the Government of India D.O. Letter No.G-20011/01/2015-RH (A/c), dated 25.01.2017, had communicated additional target of 44,507 houses under PMAY(G) 2016-2017, in addition to the initial target of 1,31,831 and thus total allocation of houses is 1,76,338 for the Financial Year 2016-17

- Deputy Secretary (RH), MoRD, Government of India in Letter No.J-12034/03 /2016-RH (A/c)-2, 2/A, 2/B-TN, dated 16.9.2016, Letter No.J-12034/03/2016-RH (A/c)-3, 3/A & 3/B-TN, dated 31.03.2017 and Letter No.J-12034/03/2016-RH (A/c)-1, 1/A & 1/B-TN, dated 27.04.2017 have released the 1st installment of Central share. funds to the beneficiaries through PFMS and 1st installment of 3.5% of Admin cost (both Central & State share), RCC Roofing cost (only for 1,31,831 houses) has been released to all Districts through ECS. The Director of Rural Development and Panchayat Raj had sent necessary proposal to Government of India for the release of Rs.660.20 crore as 2nd Installment of central share under PMAY(G) for the year 2016-17 to Tamil Nadu. Accordingly, Government of India have released a sum of Rs.644,93,26,100/- including 4% admin cost directly to State Nodal Account of Tamil Nadu as 2nd installment towards central assistance for the FY 2016-17 under PMAY(G), leaving a balance of Rs.15.27 crore only which is also expected to be released shortly. The above amount has been credited into our State Nodal Account on 14.03.2018 (Rs.318.22 crore) and 16.03.2018 (Rs.326.72 crore). The details of 2nd installment of Central share released are furnished below:-

The Director of Rural Development and Panchayat Raj has therefore requested the Government to accord sanction for a sum of Rs 880,98,46,480 (State Share of Rs.440,13,96,480 + State Additional fund for RCC Roofing cost of Rs.440,84,50,000) and issue necessary orders empowering the Director of Rural Development and Panchayat Raj to draw the above funds towards the 2nd installment of State share under PMAY(G) for the year 2016-17.

The Government, after careful examination of the proposal of the Director of Rural Development and Panchayat Raj sanction and release a sum of Rs 880,98,46,480/- (Eight Hundred and Eighty Crore Ninety Eight Lakh Forty Six Thousand Four Hundred and Eighty only) (State Share of Rs.440,13,96,480 + State Thousand fund for RCC Roofing cost of Rs.440,84,50,000) towards the 2nd installment Additional fund for RCC Roofing cost under PMAY(G) for the year 2016-17 and of State share and RCC Roofing cost under PMAY(G) for the year 2016-17 and authorize the Director of Rural Development and Panchayat Raj to draw the fund from the Pay and Accounts Officer (South).
