### ORDER:

In the letter read above the Director of Rural Development and Panchayat Raj has stated that the Government of India have communicated the physical target of 1,30,214 houses for the year 2017-18 under PMAY(G). Subsequently, the Director of Rural Development and Panchayat Raj has distributed the physical target to the districts.

2. The Director of Rural Development and Panchayat Raj has also stated that in Letter No.J-12034/01/2018-RH(A/c)-1, 1/A & 1/B-TN, dated 23.04.2018 the Government of India have sanctioned a sum of Rs.487.52 crore towards the 1<sup>st</sup> installment of Central share including 4% admin cost under PMAY(G) 2017-18 as detailed below:-

assistance under PMAY(G) 2017-18, corresponding state share and state additional fund for RCC Roofing cost as summarized below has to be sanctioned.

The Director of Rural Development and Panchayat Raj has therefore requested the Government to accord sanction for a sum of Rs.1138,07,03,440 (Central share of Rs.487,52,12,000 + State Share of Rs.325,01,41,440 + State Additional fund for RCC Roofing cost of Rs.325,53,50,000) and also requested to empower the DRD&PR to draw the above funds towards the 1<sup>st</sup> installment of Central and State share under PMAY(G) 2017-18.

5. The Government, after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, accord sanction for a sum of Rs.812,53,53,440/- (Rupees Eight hundred and Twelve Crore Fifty Three Lakh Fifty Three Thousand Four Hundred and forty only [Central share of Rs.487,52,12,000 + State Share of Rs.325,01,41,440]) excluding the RCC Roofing cost towards 1<sup>st</sup> installment of Central and State share including 4% admin cost under PMAY(G) for the year 2017-18.
