#### ORDER:

In the letter 1<sup>st</sup> read above, the Government of India have communicated the physical target of 1,30,214 houses for the year 2017-18 under Pradhan Mantri Awaas Yojana(Gramin).

- 2. In the letter 2<sup>nd</sup> read above, the Government of India have sanctioned a sum of Rs.487.52 crore towards the 1<sup>st</sup> installment of Central share including 4% administrative cost under PMAY(G) 2017-18.
- 3. In the Government Order 3<sup>rd</sup> read above, the Government have accorded sanction for the release of Rs.812,53,53,440 as 1<sup>st</sup> Installment towards central and State share under Pradhan Mantri Awaas Yojana(Gramin) for the year 2017-18, leaving a balance amount of the 1<sup>st</sup> installment of State Additional fund for RCC Roofing cost to the tune of Rs.325,53,50,000.
- 4. In the letter 4<sup>th</sup> read above, the Director of Rural Development and Panchayat Raj has stated that as on date, most of the houses taken up under Pradhan Mantri Awaas Yojana(Gramin) 2017-18 are in advance stages of progress. As per AwaasSoft report dated 11.12.2018 for Pradhan Mantri Awaas Yojana (Gramin) 2017-2018, the details of

bills paid to beneficiaries and house completion are detailed below:-

1 <sup>st</sup> Installment bills paid (Basement)	79,143
2 <sup>nd</sup> Installment bills paid (Lintel level)	49,956
3 <sup>rd</sup> Installment bills paid (Roof laid)	34,255
4 <sup>th</sup> Installment bills paid (Completed)	20,678
5 <sup>th</sup> Houses completed (Physically completed)	24,738

- 5. The Director of Rural Development and Panchayat Raj has therefore requested the Government to accord sanction for a sum of Rs.325,53,50,000/- as 1<sup>st</sup> Installment of State Additional Fund for RCC Roofing cost under Pradhan Mantri Awaas Yojana (Gramin) for the year 2017-18.
- 6. The Government, after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, accord sanction for a sum of Rs.95.76 Crore (Rupees Ninety five Crore and Seventy six Lakh only) towards 1<sup>st</sup> installment of State Additional Fund for RCC Roofing Cost under PMAY(G) for the year 2017-18.
- 7. The expenditure sanctioned in para 6 above shall be debited under the following heads of account:-
