ORDER:

In the letter first read above, Ministry of Rural Development, Government of India had communicated the physical target of 1,30,214 houses for the year 2017-18 under Pradhan Mantri Awaas Yojana (Gramin).

2. In the letter second read above, the Government of India have sanctioned a sum of Rs.487.52 crore towards the 1st installment of Central share including 4% administrative cost under Pradhan Mantri Awaas Yojana (Gramin) 2017-18.

3. In the Government Order third read above, the Government have accorded sanction for the release of Rs.812,53,53,440 as 1st installment of Central and State share under Pradhan Mantri Awaas Yojana (Gramin) for the year 2017-18, leaving a balance of Rs.325,53,50,000/-

4. In the Government Order fourth read above, Government have accorded sanction for the release of Rs.95,76,00,000/- as the part of 1st installment of State Additional fund for RCC Roofing cost leaving a balance of Rs.229,77,50,000/-.

5. In the letter fifth read above, the Director of Rural Development and Panchayat Raj has stated that most of the houses taken up under Pradhan Mantri Awaas Yojana (Gramin) 2017-18 are in advance stages of progress. The Director of Rural Development and Panchayat Raj has therefore requested the Government to sanction a sum of Rs.229,77,50,000/- (Rupees two hundred and twenty nine crore seventy seven lakh fifty thousand only) as balance part of 1st Installment of State Additional Fund for RCC Roofing cost under Pradhan Mantri Awaas Yojana (Gramin) for the year 2017-18 so that payment to all beneficiaries can be made based on the actual progress of the houses.

6. The Government, after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, accord sanction a sum of Rs.229,77,50,000/- (Rupees two hundred and twenty nine crore seventy seven lakh fifty thousand only) as balance part of 1st Installment of State Additional Fund for RCC Roofing cost under Pradhan Mantri Awaas Yojana(Gramin) for the year 2017-18.

7. The expenditure sanctioned in para 6 above shall be debited under the following heads of account:-
