Subject: Wide circulation of sanction orders and universal geo-tagging of PMAY-G houses- reg.

Dear Sir/Madam,

As you are aware that Pradhan Mantri Awaas Yojana-Gramin (PMAY-G) is one of the flagship schemes of the Government of India which aims to provide a pucca house with basic amenities to all eligible houseless households and households living in kutcha and dilapidated house in rural areas by March 2024.


2. In this context, I would like to apprise you that, since the inception of the scheme, to ensure greater efficiency and result-oriented outcomes under PMAY-G, continuous efforts are being made by the Ministry to make the scheme more transparent and accessible to the beneficiaries. Therefore, conforming to this commitment, following two additional provisions have been made under PMAY-G for making the scheme further beneficiary oriented:

- i. **Wide circulation of sanction order:** The sanction orders of PMAY-G beneficiaries can be downloaded through PMAY-G website, RURBAN website and Citizen Centric App by the beneficiary or with the assistance using the registered mobile number of the beneficiary. Additional source of getting the access to sanction order of beneficiaries shall ensure in-time and easy dissemination of information to the beneficiaries. Further, The existing manpower of RURBAN may also be utilized for providing the sanction order to PMAY-G beneficiaries, which would further ensure the in-time and easy dissemination of information regarding sanction to the beneficiaries.
- ii. **Sharing of sanction orders with SHGs:** SMSs are sent to SHGs on daily basis informing about details of beneficiaries who got sanction of PMAY-G houses in the GPs.
- iii. **Universal geo-tagging of PMAY-G Houses:** Geo tagging of houses is one of the prominent features of PMAY-G scheme, which is being done through Awaassoft/AwaasApp. However, keeping in view the problems faced by the States/UTs in geo-tagging leading to delays in the house construction of beneficiaries, the facility has also been provided in GeoRURBAN app. In absence of AwaasApp/soft or employee of PMAY-G in the vicinity, geo-tagging of the house can also be done through GeoRURBAN app using the existing manpower of RURBAN Mission apart from the PMAY-G manpower at the ground level. The provision has been added to expedite construction of houses for the beneficiary.

3. Since, these newly added provisions will further lead to increase in the transparency and accessibility of the scheme to the PMAY-G beneficiaries, I would like your personal intervention and request you to kindly direct the concerned ground level staff to take every necessary steps, so that the newly added provisions may be adequately circulated among the respective PMAY-G officials and other scheme's stakeholders, as well as eligible PMAY-G beneficiaries to avail the maximum benefit of the Scheme.
