ORDER:

In the letter first read above, the Ministry of Rural Development, Government of India had communicated the physical target of 21,000 houses for the year 2018-19 under PMAY(G) and it has been allotted to all districts.

2) In the letter 2nd read above, Ministry of Rural Development, Government of India, have communicated the physical target of 2,00,000 houses for the year 2019-20 under PMAY(G) and the same has been allocated to all Districts. Further, the Ministry of Rural Development, Government of India, in the letter third read above, have allocated 2,89,887 houses for Tamil Nadu from the finalized "Awaas+" list of PMAY(G) for the Financial Year 2021-22. The category wise target for the years 2018-19, 2019-20 &

2021-22 allocation are as detailed below:

3) In the letter 5th read above, the Ministry of Rural Development, Government of India have released a sum of Rs.1004.526 crore against entitlement of Rs.3678.386 crore and further the Ministry of Rural Development, Government of India have released a sum of Rs.667.457 crore towards programme fund as 1st Tranche of 1st installment of Central Assistance for the year 2022-23. Accordingly, in the Government orders 6th and 7th read above, orders have released Rs.1112.4281 crore which includes Central share (60%) of Rs.667.457 crore and State share (40%) of Rs.444.9712 crore towards 1st tranche of 1st Instalment for the year 2022-23.

4) In the letter 8th read above, the Commissioner of Rural Development and Panchayat Raj has stated that the Additional fund of RCC Roofing cost is being released to the beneficiaries for the purchase of materials like Cement, Steel, Doors and Windows etc., so that it will be helpful to the poor beneficiaries to speed up the construction of the houses. The Government have released the entire amount of RCC Roofing Cost for the year 2016-17 & 2017-18 and the same has been released to the Districts.

5) In the Government order 4th read above, the Government have released a sum of **Rs.605 crore** towards RCC Roofing cost for the years 2018-19 & first instalment of 2019-20 as detailed below and the same has been released to all the Districts.

6) In the letter 8th read above, the Commissioner of Rural Development and Panchayat Raj has stated that based on the percentage of release of Unit cost by Government of India, the State Government is requested to release a sum of **Rs.555,99,07,075/- (Rupees Five hundred and Fifty-Five crore Ninety-Nine Lakh Seven Thousand and Seventy-Five only)** towards RCC Roofing Cost for the years 2018-19, 2019-20 and 2021-22. Further, the Government have made necessary provision in the Budget Estimate 2022-23 under PMAY(G) RCC Roofing Cost as detailed below:

7) The Commissioner of Rural Development and Panchayat Raj has therefore requested the Government to authorize him to draw the funds from the PAO (South), Chennai and disburse the amount to all the Districts.

8) The Government after careful examination of the proposal of the Commissioner of Rural Development and Panchayat Raj, have decided to accept the same and to authorize the Commissioner of Rural Development and Panchayat Raj to draw a sum of Rs.555,99,07,075/- **(Rupees Five hundred and Fifty-Five crore Ninety-Nine Lakh Seven Thousand and Seventy-Five only)** under the following head of accounts from the PAO (South), Chennai and disburse the amount to all the District Collectors except Chennai / The Commissioner of Greater Chennai Corporation.

9) The Expenditure sanctioned in para 8 above, shall be debited to the following Heads of account.
