In the Letter read above, the Director of Rural Development and Panchayat Raj has stated that in the Letter No.S-12011/1/2017-SBM, dated 02.5.2017 of Under Secretary, Ministry of Drinking Water and Sanitation, Swachh Bharat Mission(Gramin), Government of India have indicated Rs.514.14 Crore as initial allocation to the State of Tamil Nadu for the execution of work under Swachh Bharat Mission(Gramin) during the financial year 2017-18 and also informed that this allocation is only tentative and the allocation will be revised at later stage based on the availability of supplementary grants at Revised Budget and also on the basis of performance of the State during the current financial year.

2. The Director of Rural Development and Panchayat Raj has also stated that, the Government of India have released a sum of Rs.242,86,98,000/- to the State Government towards first instalment of Grants-in-aid as Central Share under Swachh Bharat Mission(Gramin) for the year 2017-18 as detailed below:
