Swachh Bharat Mission(Gramin) – Release of additional Grants-in-aid of Central Share under SBM (G) released to the State Government of Tamil Nadu from Extra Budgetary Resources (EBRs) Funds – Release of corresponding State Matching Share of Rs.206,49,33,000/- for the year 2018-19 – Sanction accorded – Orders – Issued.

ORDER:

In the letter read above, the Director of Rural Development and Panchayat Raj has stated that the Government of India has sanctioned Rs.309,74,00,000/- from the Extra Budgetary Resources (EBRs) funds through the National Centre for Drinking Water, Sanitation and Quality (NCDWS&Q) (a society under MDWS) to the State Government of Tamil Nadu towards Extra Budgetary Resources (EBR) as additional Grants-in-aid under Swachh Bharat Mission (Gramin) during 2018-19 on account of reimbursement of Central share for Left out of Baseline Survey 2012-13 Households as approved by National Scheme Sanctioning Committee (NSSC) under SBM(G) during 2018-19. As per the direction of Government of India, the National Centre for Drinking Water, Sanitation and Quality (NCDWS&Q) (a society under MDWS) has transferred Rs. 309,74,00,000/- directly to the Account already opened EBR Saving Bank account No.6700112207 operated in Indian Bank, Thiruvannamiyur Branch, instead through the State Government on 29.03.2019

2. The Director of Rural Development and Panchayat Raj has also stated that as per Government of India's Sanction Order, the State Government shall ensure release / transfer the State Matching Share for the aforesaid Central Share amount to the State Level Implementing agency(s) immediately (maximum within 15 days) after the Central Share amount is credited to the account of State Level Implementing Agency. Further, the expenditure out of the EBRs funds would be incurred for construction of Individual Household Latrines (IHHLs), Community Sanitary Complexes (CSCs) and for Solid and Liquid Waste Management (SLWM) projects only as per the approval of Annual Implementation Plan (AIP) for 2018-19 and compliance of the Government of India guidelines for utilization of funds for SC, ST components shall be ensured by the State Government.

3. The Director of Rural Development and Panchayat Raj has further stated that as per the revised sharing pattern (60 : 40) under SBM (G), as against the additional Grants-in-aid of Central Share of Rs.309,74,00,000/- (60%), corresponding State Matching Share is worked out to Rs.206,49,33,000/- (40%).

4. The Director of Rural Development and Panchayat Raj has therefore requested the Government to sanction the corresponding State Matching Share of Rs.206,49,33,000/- under SBM(G) for the year 2018-19 and authorize the Director of Rural Development and Panchayat Raj to draw the above amount and credit it into the SB Account No.6700112207 maintained at Indian Bank, Thiruvanmiyur Branch in the name of "DRD&PR – EBR A/c" funds for release of both Central and State Share to the Districts based on their requirements.

5. The Government, after careful examination, accord sanction and release the State Matching Share of Rs.206,49,33,000/- (Rupees Two hundred and six crore forty nine lakh and thirty three thousand only) against the Central Share of Rs.309,74,00,000/- as additional Grants-in-aid under SBM (G) for the year 2018-19.

6. The expenditure sanctioned in para 5 above shall be debited under the following heads of account:
