ORDER:

In the Government Order first read above, the Government have released a sum of Rs.57.4784 Crore (Rupees Fifty Seven Crore Forty Seven Lakhs and Eighty Four Thousand only) released by the Government of India to the State Government of Tamil Nadu as Central assistance under Pradhan Mantri Gram Sadak Yojana Phase IX for the year 2017-18.

- 2. In the letter second read above, the Director of Rural Development and Panchayat Raj has stated that the Government of India has revised the sharing pattern under Pradhan Mantri Gram Sadak Yojana which was communicated by Ministry of Rural Development of Government of India in November 2015. In the revised ratio of funding the share of Government of India and State for 2017-18 for Pradhan Mantri Gram Sadak Yojana has been intimated in Letter No.P-17017/4/ 2017-RC dated 22.02.2017 of Ministry of Rural Development. According to the communication, the Centre's Share for 2017-18 is Rs.400.00 Crore and State Share is Rs.266.67 Crore. The Ministry of Rural Development has released a sum of Rs.57.4784 Crore out of 400 Crore for 2017-18. Since the scheme is to be funded by both Centre and State, the State Share to that extent need to be released. The State Share allotted by Ministry of Rural Development is Rs.266.67 Crore for the year 2017-18.
- 3. The Director of Rural Development and Panchayat Raj has requested the Government to release the Pradhan Mantri Gram Sadak Yojana programme fund matching

State Share to the extent of Central release of Rs.38.29 Crore (14.36%), so as to speed up the completion of the works which are in advanced stages.

- 4. The Government after careful examination have decided to accept the proposal of Director of Rural Development and Panchayat Raj and accord sanction to release a sum of Rs.38.29 crore (Rupees Thirty Eight Crore and Twenty Nine Lakh only) as corresponding State matching share under Pradhan Mantri Gram Sadak Yojana for the year 2017-18.
- 5. The expenditure sanctioned in para 4 above shall be debited under the following head of account:-

4515-00-Capital outlay on Other Rural Development Programmes - 103 Rural Development -State's Expenditure - JG-Road/Bridge works under PMGSY-Bharat Nirman -16 Major works. (DPC 4515-00-103-JG-1608)

- 6. The Director of Rural Development and Panchayat Raj is authorized to draw and disburse the amount sanctioned at para 4 above.
