ORDER:

The Director of Rural Development and Panchayat Raj, in the letter read above, has stated that the Government of India approved the AIP 2014-15 and indicated the initial allocation of Rs. 205.11 crore for Tamil Nadu under Nirmal Bharat Abhiyan (NBA). Now, Nirmal Bharat Abhiyan has been restructured as Swachh Bharat Mission (Gramin) with effect from 2nd October 2014. For the year 2014-15, the Government of India have released the Central Share through State Government. The Government of India have released Rs.62,53,98,000/- (Rs.4,22,44,000 + Rs.58,31,54,000) as a part of first installment of Grant-in-aid under Swachh Bharat Mission (Gramin) for the year 2014-15. Consequently, in G.O.(Ms) No.2, Rural Development and Panchayat Raj (CGS.1) Department, dated 12.1.2015 and G.O.(Ms) No.9, Rural Development and Panchayat Raj (CGS.1) Department, dated 27.1.2015, the Government have authorized the Director of Rural Development and Panchayat Raj to draw the above amount of Central Share of Rs.62,53,98,000/- from the Government head of account and disburse the same to the Districts along with corresponding State Matching share. Accordingly, a sum of Rs.6253.98 lakhs Central share (75%) has been released to the Districts along with Corresponding State Matching Share of Rs.2084.66 lakhs(25%).

2. The Director of Rural Development and Panchayat Raj has also stated that Government of India, have released Rs. 4001.98 lakhs (Rupees Forty crore one lakh

and ninety eight thousand only) as the balance part of first installment of Grant-in-aid under Swachh Bharat Mission (Gramin) for the year 2014-15 as detailed below:

As per Government of India guidelines, the State shall release the Central grant received along with the matching State share to the District implementing agencies / agencies [DSBM (G)] within 15 days of receipt of Central Grants.

3. The Director of Rural Development and Panchayat Raj has therefore requested the Government to authorize him to draw the balance part of first installment of Central share of Rs.40,01,98,000 (Rs. Forty crore one lakh and ninety eight thousand only) (75%) and part of first instalment of Corresponding State Matching Share of Rs.13,33,99,400/- (Rupees Thirteen Crore thirty three lakhs ninety nine thousand and four hundred only) (25%) from the above Government head of account mentioned in para 2 above and disburse the same to the Districts along with corresponding State Matching share.

4. The Government, after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, accord sanction for a sum of Rs.40,01,98,000/- (75%) (Rupees Forty crore one lakh and ninety eight thousand only) towards part of first installment of Central share under Swachh Bharat Mission (Gramin) for the year 2014-15.

5. The expenditure sanctioned in para 4 above shall be debited to the following head of account:

The Director of Rural Development and Panchayat Raj is authorized to draw and disburse to amount sanctioned in para 4 above.
