ORDER

In the letter read above the Director of Rural Development and Panchayat Raj, has stated that the Shyama Prasad Mukherji Rurban Mission (SPMRM) has been launched by Hon'ble Prime Minister on 16.09.2015 aiming at developing cluster of villages that preserve and nurture the essence of rural community life with focus on equity and inclusiveness without compromising with the facilities perceived to be essentially urban in nature, thus creating cluster of "Rurban Villages".

2. He has stated that the Government of India, Ministry of Rural Development has suggested the constitution of the State Level Empowered Committee headed by the Chief Secretary, consisting of the departments based on scheme components chosen.
