ORDER:

In the Government Order first read above, Theni – Allinagaram Local Planning Area was constituted. In the Government order second read above, the Government notifying its intention to include additional areas in the Theni Allinagaram Local Planning Area was published at pages 733 – 734 of Part II - Section 2 of the Tamil Nadu Government Gazette, dated the 5th November, 2014 and also in the Theni District Gazette, dated the 19th May, 2015 for general information as required under clause (b) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972).

2. In the Government order third read above, the said inclusion of additional areas to the Theni – Allinagaram Local Planning Area was declared under sub-section (4) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972).

3. The Director of Town and Country Planning in his letter 4th read above has requested the Government to include additional areas in the said Theni – Allinagaram Local Planning Area with certain modification including Seelayampatty cluster under clause (b) of sub-section (1) of section 10 of the said Act.

The Government, after careful consideration of the above proposal of the Commissioner of Town and Country Planning have decided to declare their intention to specify the areas mentioned in the notification appended to the order as Theni – Allinagaram Local Planning Area under clause (b) of sub-section (1) of section 10 of the said Act. The appended notification will be published in the Tamil Nadu Government Gazette.

5. The Collector of Theni District is directed to republish the Notification in the District Gazette.

6. The Director of Translation, Chennai-09 is directed to arrange to have the Notification translated into Tamil and to forward the translation urgently to the Collector of Theni District under intimation to the Government.

7. The Collector of Theni District is directed to report to Government the date of republication of the notification in the District Gazette.



APPENDIX.
NOTIFICATION.

In exercise of the powers conferred by clause (b) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu hereby declares his intention to include and remove the areas of certain revenue villages in the Theni - Allinagaram Local Planning Area and to make the following amendment to the Rural Development and Local Administration Department Notification No.II(2)/RUL/2139/74, published at page 218 of Part II-Section 2 of the Tamil Nadu Government Gazette, dated the 17th April 1974, as subsequently amended.

2. Notice is hereby given that any inhabitant or any local authority or institution in the above said areas may, within two months from the date of publication of this notification in the Tamil Nadu Government Gazette, submit any objection or suggestion in writing on the proposed amendment to the Government and that any objection or suggestion received within the said period will be considered by the Government. Objections or suggestions, if any, should be addressed to the Principal Secretary to Government, Housing and Urban Development Department, Secretariat, Fort Saint George, Chennai-600 009.


