### ORDER:

In the letter sixth read above, the Government of India released a sum of Rs.36,19,00,000/- (Rupees Thirty Six crore and Nineeteen Lakh Only) as Central Share (60%) under Shyama Prasad Mukherji Rurban Mission. The total fund required along with State Matching Share was Rs.60.32 crore. However, in the Government order seventh read above, a sum of Rs 33.44 crore (Rs.21.60 crore as Central Share and Rs.11.84 crore as State Share) was released under Shyama Prasad Mukherji Rurban Mission for the year 2021-22.

- 2. In the letter 8<sup>th</sup> read above, the Director of Rural Development and Panchayat Raj has requested the Government to issue necessary orders on the following:-
  - (i) To release a sum of Rs.26.88 crore (Rs.14.59 crore as Central Share and Rs.12.29 crore as State Share) under Shyama Prasad Mukherji Rurban Mission for the year 2021-22.
  - (ii) To authorize the Director of Rural Development and Panchayat Raj to draw the sanctioned amount and maintain the funds in the account of State Nodal Agency for the purpose of utilization of funds through PFMS for Rurban Clusters under Shyama Prasad Mukherji Rurban Mission for the year 2021-22.
- 3. The Government after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, have decided to accept the same and accordingly, the Government sanction and release a sum of Rs. 26,88,00,000/-(Rupees Twenty six crore and eighty eight lakh only) (Rs.14.59 crore as Central Share and Rs.12.29 crore as State Share) to the account of State Nodal Agency for the purpose of utilization of funds for Rurban Clusters under Shyama Prasad Mukherji Rurban Mission for the year 2021-22.
