ORDER:

The Mission Director, State Water and Sanitation Mission, Jal Jeevan Mission and Managing Director, Tamil Nadu Water Supply and Drainage Board, has further stated that the Jal Jeevan Mission, Tamil Nadu, has taken up Japanese Encephalitis and Acute Encephalitis Syndrome (JE/AES) scheme for 444 rural habitations and there is no fund available under JE-AES in Jal Jeevan Mission as on 19-04-2021 and so far expenditure for Rs.457.30 Lakh has been incurred which is pending for payments.

The Mission Director, State Water and Sanitation Mission, Jal Jeevan Mission and Managing Director, Tamil Nadu Water Supply and Drainage Board, has therefore requested the Government to issue necessary orders for sanction and release of a sum of Rs.5,13,83,000/- (Rupees Five Crore Thirteen lakh and Eighty Three Thousand only) (Central share of Rs.2,27,36,000/- and State share of Rs.2,86,47,000/-) towards 1st installment under earmarked 0.5% fund for JE-AES affected high priority districts under Jal Jeevan Mission during the year 2020-2021 as follows:-
