ORDER:

In the letter 1st read above Ministry of Rural Development, Government of India has released Rs.27.28 Crore towards "Financial Incentive" to State of Tamil Nadu as Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the Financial Year 2022-23 for periodic maintenance of roads already constructed under PMGSY Scheme and instruct the State to transfer these funds along with the corresponding State Share of Rs.18.19 Crore to Tamil Nadu Rural Housing and Infrastructure Development Corporation (TNRHIDC).

2. In letter 2nd read above, the Commissioner of Rural Development and Panchayat Raj has requested the Government to issue orders for the release of Financial incentive for Rs.45.47 Crore (Central Share of Rs.27.28 Crore and State Share of Rs.18.19 Crore) under PMGSY for the year 2022-23 and to transfer the amount to Tamil Nadu Rural Housing and Infrastructure Development Corporation (TNRHIDC).

3. The Government, after careful examination, accept the proposal of the Commissioner of Rural Development and Panchayat Raj and issue orders for the release of Financial incentive for Rs.45.47 Crore (Forty Five Crore and Forty Seven Lakh only) (Central Share of Rs.27.28 Crore and State Share of Rs.18.19 Crore) under PMGSY for the year 2022-23 and

transfer the amount to Tamil Nadu Rural Housing and Infrastructure Development Corporation (TNRHIDC).

4. The expenditure sanctioned in para 3 above shall be debited under the following head of account

Total : 45.47 Cr


