

#### **CHAPTER - I**

## INTRODUCTION

The Rural Development Department, Government of Tamil Nadu requested the State Planning Commission for consitiuting a small Working Group of Members of the Commission which should consider and make recommendations on the responsibilities to be entrusted to the Panchaysts at different levels and the roles, duties and functions to be discharged by them. A copy of the D.O.letter No.20099/CI/96-D, dated 20.9.96, RD Dept. is enclosed (Enclosure-01) The request was considered in the First Informal Meeting of the Members of the State Planning Commission held on 27.9.'96 and it was decided to constitute a Group for suggesting entrustment of powers and responsibilities to rural local bodies.

This first report was transmitted to the Government on 06-01-97. Second report of the Group was submitted to Government on 17-3-97. Final report was approved by the Members of the SPC on 4-4-97.
